

The Los Angeles Philharmonic Association is currently seeking a: Student Life Manager – YOLA National Festival & Encuentros

Founded in 1919, the Los Angeles Philharmonic Association presents, and promotes the performing arts in its varied forms at the highest level of excellence to a diverse and large audience, at Walt Disney Concert Hall, the Hollywood Bowl, and The Ford.

About the YOLA Program:

YOLA is Music and Artistic Director Gustavo Dudamel's signature program. YOLA was inspired by El Sistema, the music education system which provides young people with free musical instruments and intensive musical instruction in Venezuela. Central to YOLA's mission is the promotion of healthy growth and development through the study, practice and performance of music. Simultaneously, YOLA positively invests in each child's development as a musical ambassador of peace, hope, and understanding amongst a diverse population of cultures, backgrounds and beliefs. YOLA currently serves more than 1,500 elementary, middle, and high school students throughout Los Angeles.

YOLA National Festival 2022:

This July, the LA Phil will be hosting the [YOLA National Festival](#) (YNF) and [Encuentros](#) youth-centered music festivals in Los Angeles, CA. The YOLA National Festival invites over 170 musicians ages 12-18 from El Sistema-inspired programs throughout the United States to perform as part of a top-tier, national youth orchestra. Musicians will convene for 12 days of learning with world-renown faculty, guest artists, and conductors.

Encuentros is the Dudamel Foundations international music festival open to international musicians ages 18-26. Under the leadership of Gustavo Dudamel and María Valverde, this summer's Encuentros program will take place in Los Angeles, the first time the festival takes place in the US. Encuentros will be made up of over 90 musicians from 25 countries.

All travel, lodging, and meals are provided at no cost for participating musicians. Both YNF and Encuentros will be housed on the campus of the University of Southern California (USC) and will have engagements at the Beckmen YOLA Center, Walt Disney Concert Hall, and the Hollywood Bowl.

Position Summary:

The Student Life Managers for Encuentros and the YOLA National Festival are part-time, seasonal position from July 15 – August 3, 2022 in Los Angeles, CA. The Student Life Manager will work in conjunction with the Culture and Residential Life Director, and LA Phil staff to ensure highly organized, safe and exciting residential life experience for YNF and Encuentros participants. This includes creating a sense of off-stage community, managing residence hall life, and implementing safety and security measures that ensure participants have the supervision and support they need.

This position will include evening and weekend responsibilities. This is a live-on campus position during the festival dates of July 15-August 3rd.

All flights, lodging, meals, and transportation will be provided by the LA Phil.

Sample Schedule for Festival:

Festival activities will include a broad range of events with a primary focus on rehearsals and preparation for performances. Musicians will spend most of the day (approx. 8 hours) in rehearsals and have 4-5 hours of free time to include cultural excursions, chamber ensemble rehearsals and other activities as designed by the ResLife team. Additionally, there will be three days that the ResLife team can program full-day activities for participants in the festival.

Position Elements:

Management/Supervision

- The Student Life Manager is responsible for supervising YOLA National Festival Residential Advisors (RA's) in conjunction with the Culture and Residential Life Director.
- The Student Life Manager will report directly to the Culture and Residential Life Director
- The Student Life Manager will liaise student life activities and needs with Encuentros musicians

This position will include evening and weekend responsibilities

Operations:

- Implement student life programs as directed by the Culture and Residential Life Director.
- Ensure that the implementation of programs are in line with the safety protocols of YOLA and LA Phil
- Build activity systems and implement them with the support of the Student Life Managers and RA's.
- Manage Student Life Staff
 - Design and implement Student Life Staff Training
- Oversee Student Residence Life Program
 - Coordinate housing check-in, check-out process
 - Implement rooming assignments
 - Coordinate mealtimes and processes, including offsite or catered meals as needed
 - Liaise disciplinary action to students as necessary
 - Coordinate camp movement from USC to Walt Disney Concert Hall and Beckmen YOLA Center, and work with Transportation Coordinator and Culture and Residential Life Director on daily transportation needs on bus hire and distribution, rooming assignments, and luggage movements for arrival and departure from LAX
 - Manage wardrobe sizing and distribution
- Other duties as assigned

Position Requirements:

- Excellent organizational, analytical, written, and verbal communication skills
- Bilingual (English/Spanish) communication
- Detail oriented with strong interpersonal skills and a desire to work on a highly collaborate, intrinsically motivated team
- Experience coordinating youth focused programs and implementing systems to achieve programmatic goals
- Excellent problem-solving skills and a solutions-oriented approach to challenges
- Ability to prioritize workload, efficient and effective worker
- Ability to work in a fast-paced environment in a self-directed way
- Fluency in all Microsoft suites components and remote working tools (Slack, Google, Zoom, etc.)
- Experience working with high school age students from diverse backgrounds is preferred
- Other duties as assigned
- Dedication and commitment to engage in and promote diversity, equity, and inclusion within the staff, vendors, and within interactions with the surrounding community is a must
