# Recent Trends in Philanthropic Giving from Arts Consulting Group

This report from Arts Consulting Group highlights research conducted in 2021 by widely regarded resources, including Giving USA, to provide context and benchmarks for understanding recent charitable giving to the arts and culture sector compared to overall nonprofit philanthropic trends. Moving forward, organizations should monitor the effects of inflation and the possibility of an economic recession, as was recently outlined in an article issued by *The Chronicle of Philanthropy*.

One major finding for the arts and culture sector was that charitable contributions in 2021 increased in about half of the recipient organization types. The arts, culture, and humanities sector received an estimated \$23.5 billion in contributions from all sources, making up 5 percent of the total contributions for 2021. This was an increase of more than 27 percent from the previous year and exceeded pre-pandemic giving to the arts.


