The **San Francisco Symphony** launched a new educational resource, Musical Heroes: Stories of African-American Composers—an exploration of the life, work, and impact of Florence Price, William Grant Still, and George Walker. Intended for students in middle school and high school classrooms and above, this presentation also includes performances by SF Symphony musicians and is accompanied by supplementary guides for classroom discussion and further exploration.

In an ongoing commitment to supporting many of today's most important musical voices, the **Fresno Philharmonic** announced the premiere of a special project: Rise Up! This monthlong video streaming series, coinciding with Black History Month, features performances and conversations between Music Director Rei Hotoda and four African American composers whose works were performed recently by the Fresno Philharmonic.


ICYOLA and LA Phil's YOLA Go to the Super Bowl; Also, Go Los Angeles Rams!


The Super Bowl isn't just for sports fans this year. Classical music lovers can get their fix too with performances by two Los Angeles-based orchestras full of gifted young musicians.

Inner City Youth Orchestra of Los Angeles (ICYOLA) will serve as the House Orchestra at the 11th Annual NFL Honors Ceremony. This prime-time awards special that recognizes the NFL's best players, performances, and plays from the 2021 season will air live nationally on ABC on Thursday, February 10 at 9:00pm PT (simulcast on ESPN+ and NFL Network). ICYOLA will perform a pre-show concert at 8:15pm PT that will feature Aaron Copland's *Fanfare for the Common Man, Crown Imperial* by William Walton, and both the *Superman March* and the *Star Wars Main Theme* by John Williams. The orchestra will also perform during the awards show.

Be sure to tune in for the game early on Sunday, February 13 because during the pre-game activities, musicians from LA Phil's Youth Orchestra LA (YOLA) will perform *Lift Every Voice and Sing* with gospel duo Mary Mary, conducted by

Thomas Wilkins, with musical direction by Derrick Hodge. This is the second time YOLA musicians will be featured at a Super Bowl in YOLA's 15-year history, including their 2016 halftime show performance conducted by Gustavo Dudamel with Coldplay.

COVID-19 Update: State Announces New Guidelines

For masking: Effective February 16, the State will revert back to requiring masking for unvaccinated individuals in public indoor settings (pre-December 15 health order), letting the current universal masking mandate to lapse on February 15. For more information, click here.

For Mega Events: Effective February 16, the State reverts back to prior definition (pre-December 31) of 1,000+ for indoor and 10,000+ outdoor to be considered in the Mega Events category. For more information, click here.

CA Venues Grants Still Under Review

Today Californians for the Arts (CFTA) shared that applications for CA Venues Grant are still under review and Lendistry anticipates this process could go through June 2022. CFTA advises all applicants to login on a weekly basis to their application and check the status of their application. Please ensure you have uploaded all of your documents, so that no documents required are left blank. In addition, CFTA recommends all applicants to check their spam/junk mail for any communication from Lendistry. NEA Awards \$500,000 in American Rescue Plan Grants to Six ACSO Member Orchestras

The National Endowment for the Arts announced on January 27 it had recommended American Rescue Plan (ARP) awards totaling \$57,750,000 to 567 arts organizations to help the arts and cultural sector recover from the pandemic. The organizations may use this funding to save jobs, fund operations and facilities, health and safety supplies, and marketing and promotional efforts to encourage attendance and participation.
