
Save the Date! ACSO Partners with League of American Orchestras on National Conference in LA, June 1 - 3

SMU Data Arts: The Effect on Arts Ticket Sales as People Opt to Stay Home

This article published recently by SMU Data Arts examines the number of people who continue to stay at home due to the ongoing Covid-19 Pandemic and the effect that it has had on ticket sales within the arts sector. Here is a summary of their findings:


- Enduring COVID-related behavioral patterns have shifted ticket demand 20-25%, half due to abstainers who are not ready to return to performing arts venues and half due to lower traffic rates and participation rates among those who have returned.
- Fluctuating COVID case rates continue to exert a strong effect on ticket demand and will likely keep performing arts organizations in a reactive posture for the foreseeable future.
- Vaccinations and boosters no longer play the "savior" role, as highly vaccinated counties (with presumably older, vulnerable populations) are purchasing fewer tickets due to reported levels of breakthrough cases.
- Price and performance levers still influence demand but within a limited range.
- If COVID case rates trend toward June 2021 levels in the first six months of 2022, predicted ticket sales reach 46% of their most recent 4-year high by June 2022.

Advocacy Call to Action from League of American Orchestras: ERTC Reinstatement Gaining Support

On February 14, our friends at the League of American Orchestras shared that support for reinstating the Employee Retention Tax Credit (ERTC) for the fourth quarter of 2021 is gaining momentum in Congress! Bipartisan bills have now been introduced in both the Senate (S. 3625) and House (H.R. 6161) that would return access to this critical form of COVID-19 relief after it was repealed prematurely in 2021. Your orchestra can join the wider nonprofit and business sectors to help gain more support for the ERTC by contacting your members of Congress and asking them to co-sponsor these bills.
